- 1) that the Products fully and in all respects correspond to and conform to the regulations of the European Chemical Directive REACH EC Directive No. 1907/2006 ("REACH") as well as its implementations into national laws. If the Supplier itself is not the manufacturer or importer of the Products, it hereby represents and warrants that not only the Supplier itself fully complies with REACH but that in addition any and all third parties from whom it receives or sources Products likewise fully conform to the Directive.
- 2) that all "Products", that it delivers to SONOPRESS which, for purposes hereof, shall include each and every entity affiliated with SONOPRESS (such entities shall hereinafter collectively be referred to as "Arvato"), that include chemicals which are required to be registered, have in fact been pre-registered and/or registered at the ECHA by the Supplier and/or any of its pre-suppliers.  
The Supplier undertakes to inform Sonopress immediately in writing of the any Products for which no registration or admission has been planned with a short explanation as to why Supplier is of the view that no such registration/ admission is needed.
- 3) that any and all Products delivered by Supplier to Sonopress do not include "Substances of Very High Concern (SVHC)" that are listed at the ECHA ([http://echa.europa.eu/consultations/authorisation/svhc/svhc\\_cons\\_en.asp](http://echa.europa.eu/consultations/authorisation/svhc/svhc_cons_en.asp)) in a concentration above 0,1% (w/w).
- 4) that all deliveries of Products to Sonopress originate from the Supplier, who is located/listed in Europe and that Sonopress will not be listed as importer into the EU.
- 5) that the Supplier will inform Sonopress continuously of its status and results regarding REACH and send Sonopress the extended safety data sheet and chemical safety report, CSR promptly after they have become available.

- 1) that is intimately familiar with, has fully reviewed and comprehends the European Chemical Directive REACH EC Directive No. 1907/2006 ("REACH") as well as its implementations into national laws.
- 2) that as a result of Supplier's careful and diligent analysis (which analysis Supplier will make available to Sonopress in written form upon request) the Products supplied to Sonopress are not subject to REACH due to the following reason:

This declaration of conformity shall become effective immediately for all current and future deliveries of Products made by the Supplier to Arvato.

In case the Supplier should be in breach of any undertakings, representations and warranties set forth herein, it shall upon Sonopress from and against any and all damages, losses, claims and other costs incurred and shall refund Sonopress any costs incurred in defending its legal position, including reasonable attorneys fees.

Any amendment to this declaration of conformity shall not be effected without Sonopress prior written consent.

This declaration shall be governed by the substantive laws of the Federal Republic of Germany without giving effect to its rules on conflict or laws. The UN Convention on the International Sale of movable goods ("CISG") shall not apply either. Jurisdiction and venue shall be vested in the district court ("Landgericht") Bielefeld, Germany.
